July has been a busy month, with the TKT Memorial Tournament and the Cameco-RBC Ladies Open Tournament. We had 152 players in the mixed and 72 for the Ladies Open.

Mondays have become almost sold out before 430 pm when the double crossover ends. We have worked hard at identifying golfers who pay for 9 holes, but play 18, especially on men's night. I will include in my report a sample letter given to those players. Our Titleist fitting day went extremely well, including several club orders. They were all prepaid, and collected. We are having a second fitting day Friday, which also is filled. This Wednesday, we are hosting a National Junior Golf Tour event. Our first Mixed night was a great success thanks to Alyssa and organizers. We had 54 people, approximately 1/3 were non-member green fee players. We are hoping to make this a weekly event going forward.

6. TOURNAMENT & LEAGUES

Alyssa explained how the first Mixed Night went with 21 Green Fees, 54 Golfers (27 teams). It was discussed that moving forward Wednesday night's will be mixed night with tee times and a Shot Gun Start at 5:15pm was set for August 30, 2023.
